- * 2 Star National R/J - A 1 Star National R/J who has officiated minimum of Referee 100 bout and Judge 160 bout in State/
Board, Zonal level, All India Boxing Championships
 - * 3 Star National R/J – A 2 Star National R/J who has officiated minimum of Referee 150 bout and Judge 200 bout in All India, Federation Cup, Inter Zonal National, Sub-Junior/Junior National Boxing Championships.
 - * T.D & Jury Eligibility of Applicants: IBF Executive Committee Members, IBF Commission Members, E.C Member State/
Board who have a record of having been registered on the IBF panel of Referees & Judges in the past together
with members of the IBF Ring Officials' Commission.
 - * 1 Star National R/J is eligible to officiate at State/ Board, Zonal level, All India Boxing Championships.
 - * 2 Star National R/J is eligible to officiate at Federation Cup, Inter Zonal National, Sub-Junior and Junior National Boxing Championships.
 - * 3 Star National R/J is eligible to officiate at Senior National, National Games, International Boxing Championships in India and will be given an opportunity to attend Clinics etc so that he gains sufficient knowledge and experience to appear for International R/J 1 Star Exams.
 - * As per AIBA guidelines, all elected members who are Executives of Federation / State Association such as Presidents, EC members, Secretary, Treasurer etc. as well as Active Boxing Coach / Team Manager are no more eligible to officiate as R/Js and they should refrain from appearing for R/J exams.
 - * The organizer will provide only Lodging facilities to all the candidates one day before and one day after the exam.
