**Competition Format** : 3 rounds of 1.5 minutes, 1 minute rest between rounds.

**Team Participation** : The Participating team may bring the 1 Coach, 1 Manager & 1 R/J.

**Medical & Weigh-in** : General weigh-in and medical examination of all boxers will be held at the venue from 0800 hrs. on July 24, 2011 and on subsequent days for those boxers who are drawn to Box.

**Draw** : Draw will be held immediately on completion of the medical & weigh-in on July 24, 2011.

**Boarding/Lodging** : Free lodging will be provided to all boxers and team officials by the organisers from July 23 – 29, 2011.

**Arrival particulars** :The organisers will have their reception booth at

Coimbatore Railway Station / Bus Stand. All teams will duly be received on arrival at Coimbatore upon receipt of prior intimation from the units to the Organizing Secretary only.

**Conveyance** : Local conveyance from Railway Station to their place of lodging and back will be provided by organisers. Transportation will be available for participants & officials to and from venue.

**Medals & Certificate** : Gold, Silver & 2 Bronze Medals will be awarded along with Diplomas in each weight category.

### **Important**

1. Team officials, boxers and Ring officials are entitled to Railway Concession Orders which are enclosed.
2. The team/officials shall not arrive at venue earlier than the July 23 and shall leave by July 29, 2011.
3. Cost of travel of all participants and team officials up to Coimbatore will be borne by the respective units.
4. Ring officials representing affiliated units must bring a letter of authority from their respective President/Secretary intimating that they have been nominated as Ring Official.
5. In case of extra member in a team, a charge of Rs. 500/- per day will be levied per head.
6. All boxers must possess their own Gum shield.
7. The Organizing Committee will provide boxing gloves, head guards and hand bandages to all boxers for all bouts.
8. Boxers who are already registered with IBF shall carry their Indent Card otherwise they should carry their original Municipality birth certificate and Age Estimate Format issued by CMO for IBF registration purpose.
9. No teams will be allowed to participate unless Affiliation/Entry fees are paid to IBF.
10. Borrowing of boxers from any other unit is strictly prohibited.
11. Boxers who do not compete for any reason whatsoever will not be permitted free Lodging and will have to pay Rs. 500/- per head per day in advance to avail of these facilities.

12. The championship will be conducted as per IBF rules.
13. Persons accompanying the team as Manager and Coach will not be permitted to officiate in the championship.
14. All teams are requested to bring two flags (6 X 3) of their Association.
15. States/Boards who have achieved NO MEDAL during last Sub- Junior Women National Boxing Championship will be permitted to field Six Boxers only.
16. Every team must have to deposit Rs. 2,000/- as security deposit for Accommodation and the same will be refunded after the event is over.
