No entry will be accepted after 07. 11. 2011 under any circumstances.

- Entry Fee** : For State & Boards Rs. 1000/- (payable to IABF only)
- Team Eligibility** : HAR, MAN, AIP, MIZ, DEL, ASM, MP and AP
- Weight Class** : As per IABF rules, a team may consist of a maximum number of 10 boxers (only 1 entry per wt. Category) will be permitted. No reserves are allowed.

- Age Eligibility** : Boxers over 17 year's up to 34 years are eligible (1995 to--).
- Competition Format** : 4 rounds of 2 minutes, 1 minute rest between rounds.
- Medical & Weigh-in** : General weigh-in and medical examination of all boxers will be held at the venue from 0800 hrs. on February 17, 2012 and on subsequent days for those boxers who are drawn to Box.
- Draw** : Draw will be held immediately on completion of the medical & weigh-in on February 17, 2012.
- Team Participation** : The Participating team bring the 1 Coach 1 Manager and 1 R/J.
- Boarding/Lodging** : Free board and unfurnished lodging will be provided to all boxers and team officials by the organisers from February 16 – 20, 2012.
- Arrival particulars** : The organizers will have their reception booth at Guhwati Railway Station. All teams will duly be received on arrival at above Railway Stations upon receipt of prior intimation from the units to the Organizing Secretary only.

Important

1. Team officials, boxers and Ring officials are entitled to Railway Concession Orders which are enclosed.
2. The team/officials shall not arrive at venue earlier than the February 16 and shall leave by February 20, 2012.
3. Cost of travel of all participants and team officials up to Guhwati will be borne by the respective units.
4. In case of extra member in a team, a charge of Rs. 500/- per day will be levied per head.
5. All boxers must possess their own Gum shield.

6. The Organizing Committee will provide boxing gloves, head guards to all boxers.
7. Every team must have to deposit Rs. 2,000/- as security deposit for accommodation and the same will be refunded after the event is over.
8. Entry forms (both by number & by name) should be sent to the organizers as per the Entry close duly signed by the Secretary/President of the respective units.
