We wish to inform you that the Delhi High Court directed IABF in a suit filed by BFI not to use the words, "India or Indian".

The Hon'ble Delhi High court ordered that this suit cannot be tried as commercial suit.

Indian Olympic Association has said as per directives of International Olympic Committee, Indian Olympic Association grants affiliation to BFI.

Annexure

As per International Olympic Committee charter article 3 (refer page 20), International Olympic Committee cannot provide directives regarding granting of Affiliation/dis-Affiliation to any National Sports Federation (Boxing).

An affidavit given by Union of India/Ministry of Youth Affairs and Sports dated 15.07.2022 in Hon'ble Delhi High court stated that BFI is not following National Sports Development Code 2011.

For the purposes of promoting Amateur Sports worldwide, International Olympic Committee granted affiliation to AIBA and CSIT. IOC has suspended AIBA in June 2019 which subsists till date. CSIT is currently the only International Sports Organization affiliated with International Olympic Committee and promoting Amateur Sports.

International Workers and Amateurs in Sports Confederation (CSIT) have been promoting sports all across the globe since 1913 and is also recognized by International Olympic Committee (IOC) since 1986. CSIT has granted membership to Indian Amateur Boxing Federation (IABF) to promote amateur sports in India.
