No entry will be accepted after 10<sup>th</sup> December, 2017 under any circumstances.

- Entry Fee** : Rs. 1000/- (payable to IABF)
- Weight Class** : A team may consist of a maximum number of 10 Boxers.  
No reserve are allowed.
- Boxer Eligibility** : Boxers between the age of 17 and 18 according to their year of birth (born between January 1<sup>st</sup>, 1999 and December 31<sup>st</sup>, 2000) are eligible to participate in the competition.
- Weight Categories** : 45 kg - 48 kg, 51 kg, 54 kg, 57 kg, 60 kg, 64 kg, 69 kg, 75 kg, 81 kg, 81+ kg.
- Competition Format** : Three (3) rounds of 3 minutes, (one) 1 minute rest between rounds. AIBA's 10 points must scoring system shall be followed. Championship will be conducted as per AIBA's AOB Technical & Competition Rules.



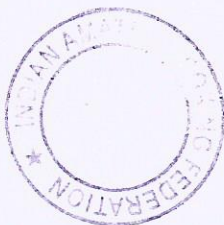



- Medical & Weigh-in** : General weigh-in and medical examination of all boxers will be held at the venue from 8 to 10 AM on 20<sup>th</sup> December, 2017 and on subsequent days for those boxers who are drawn to Box from 0800 hrs. to 0900 hrs.
- Draw** : Draw will be held immediately on completion of the medical & weigh-in on 20<sup>th</sup> December, 2017.
- Boarding/Lodging** : Free Boarding/Lodging will be provided to all boxers and team officials by the organizers from December 19 - 25, 2017.
- Team officials** : 1-5 Boxer(s) – 1 Coach-cum-Manager  
6-10 Boxer(s) – 1 Coach & 1 Manager
- One R/J will be allowed per team.
- Arrival particulars** : The Organisers will have their reception booth at Furkating or Golaghat Railway Station / Bus Stand. All team(s)/ official(s) will duly be received on arrival at Furkating or Golaghat Railway Station upon receipt of prior intimation from the State/UT/ Board(s) to the Organising Secretary.

**Important**

1. The team/officials shall not arrive at venue earlier than the 19<sup>th</sup> December and shall leave by 25<sup>th</sup> December, 2017
2. Cost of travel of all participants and team officials up to Golaghat will be borne by the respective units.
3. IABF R/J representing affiliated units must bring a nomination letter from their respective units President / Secretary intimating that they have been nominated as R/J
4. No teams will be allowed to participate unless Affiliation/Entry fees are paid to IABF.
5. The championship will be conducted as per AIBA rules.
6. Every team must have to deposit Rs. 2,000/- as security deposit for accommodation and the same will be refunded after the event is over.
7. All boxers must possess their own Gum shield, Red & Blue Vest & Shorts according to their respective corner allocation.
8. No type of body piercing and body accessories is allowed to be worn during the bout.
9. Borrowing of boxers from any other unit is strictly prohibited.
10. Boxers shall carry Medical Record Book otherwise they should carry their Original Municipality birth Certificate, Aadhar Card and School Certificate in which Father's Name, Mother's Name, Admission No., Admission years, Class and Date of birth.
11. Persons accompanying the team as Manager or Coach will not be permitted to officiate as TO/RJ in the Championship.

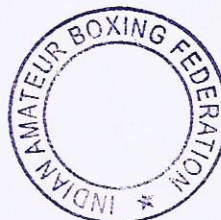
